Definitions:

Please check the box below that best represents your business.

- Farm Product Vendor -Farmers/Producers** who have the cost of planting a crop or raising an animal for the intent of income. This category includes: Fruit; vegetables; meat; poultry; eggs; cheese; honey; maple syrup; plants & flowers. This also includes vendors who have done canning; preserves and sauces made 100% from their produce for added value sales. Vendors may also sell their own meat processed by qualified means that meet health regulations. Food has to be prepared in a Health inspected kitchen and must meet regulated standards. A Food Handler's certificate is preferred. Please visit the www.simcoemuskokahealth.org to complete the Food Vendor Application Form.

- VQA/Cider/Brewery/Spirits**– Wineries are permitted to sell VQA wine, fruit wine, honey wine (mead) and/or maple wine; apple cider, spirits & beer. These products have to be 100% produced in Ontario as defined in Ontario Regulation 720 made under the *Liquor Licence Act* at Ontario farmers' markets.

- Vendor Resellers - Baking/Canning/Sauces**- Someone who buys local produce/goods, or imports goods to 100% make/bake/can/blend to sell. This may require supplementing with locally purchased produce to create their product. Food has to be prepared in a Health inspected kitchen and must meet regulated standards. A Food Handler's certificate is preferred and may be given preference. Please visit the www.simcoemuskokahealth.org to complete the Food Vendor Application Form.

- Artisan/Crafter** – means an individual engaged in the production of handmade goods, art, jewelry, and similar items, including but not limited to artists, candle and soap makers, painters, photographers, potters, quilters, knitters, sculptors, stained glass makers, weavers, leather crafters and woodworkers.

- Food vendors** – Sales of food for immediate consumption. May require supplementing with locally purchased produce to bake/can. The prepared food is packaged and kept at proper temperatures as per Health Regulations. Food has to be prepared in a Health inspected kitchen and must meet regulated standards. A Food Handler's certificate is preferred and may be given preference. Please visit the www.simcoemuskokahealth.org to complete the Food Vendor Application Form.

Vendor Options:

All vendors will pay a \$40 Marketing Administration fee regardless of seasonal or weekly.

- All fees are inclusive of applicable HST
- You will be invoiced in April, 2025
- Community booths are exempt from any costs or fees
- All vendors are required to have a canopy tent and weights. If you do not own one, you must rent one from Clearview Township.



Seasonal Vendors:

\$250 for a Single Seasonal booth or \$400 for a Double Seasonal booth. If you attend 80% of the market dates, 10 / 13 markets, you will receive an attendance incentive valued at 50% of your booth cost.

Refer a friend program (New this year!)

Seasonal vendors can earn 10% off their booth cost when they refer a new vendor to Music, Market & Park it! *New vendor must be approved and become a seasonal vendor to qualify* Maximum 1 referral per vendor.

Weekly Vendors:

Not eligible for the attendance incentive program or refer a friend program. \$35 every week you attend for a single booth. \$50 every week you attend for a double booth. *Must be paid in advance.

Vendor Layout

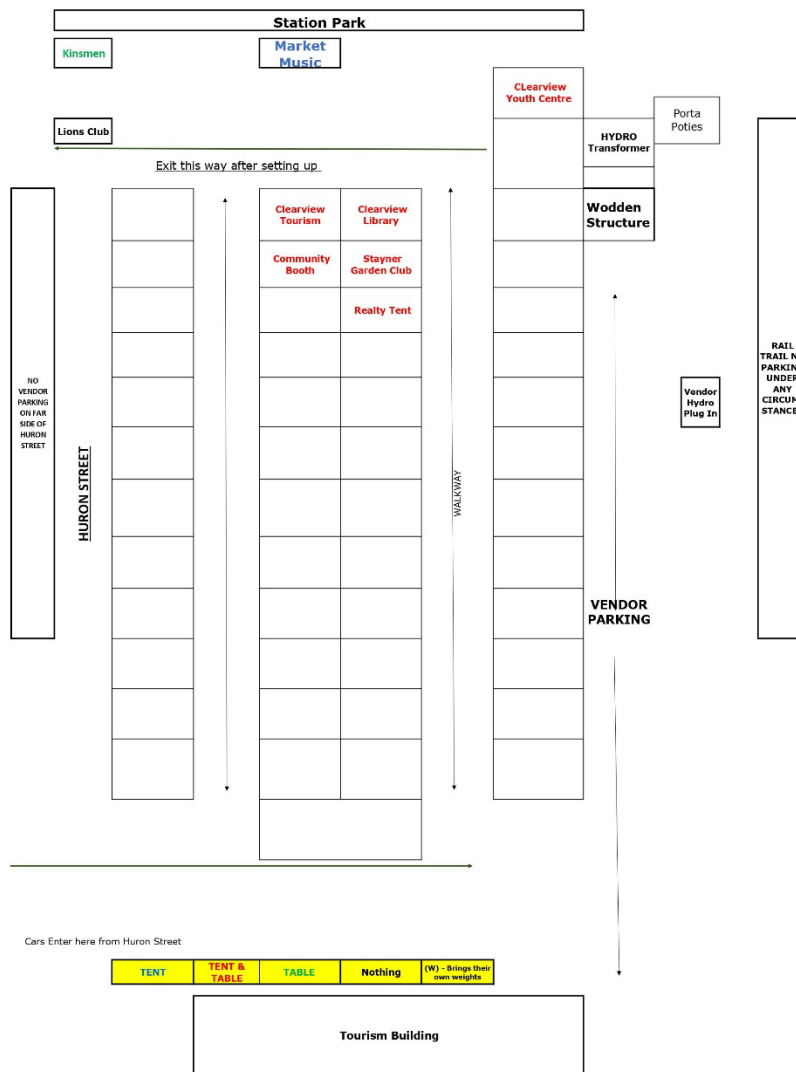
On the next page is a map of Music, Market & Park it, please select your desired location and 2 back up locations. Vendor locations will be provided on a first come first serve basis. Reasonable exceptions can be made at the discretion of the Market Manager. Once you are assigned a location, that will be your spot for the entire season.

Note: *Returning vendors have the right to reserve their previous vendor location and will take priority over new vendors.

Info to consider before selecting:

- The sun shines from left to right in this diagram
- Row 1 (furthest left), will have parking on Huron St. (closed) directly behind their booth
- All hydro vendors will be placed in row 4 (furthest right)
- Row 4 also has parking directly behind the booth
- Generators are permitted in the market. However, if a vendor uses a generator they will be placed as far away from Station Park (the busiest area of the market) as reasonably possible, regardless of selection.
- Rows 2 & 3 will have reserved parking at the end of row 4 (Note* this diagram is not to scale, there is much more room than pictured)
- If you are planning on having a double booth, please select 2 boxes side by side as your selection,
- This map will be updated as frequently as possible to show spots that have been taken
